- 1) The participant(s) for this event will be randomly selected from those in attendance at the named event(s), or by a **selection process approved by the Insurer.**
- 2) If eliminations are required, the minimum distance for eliminations is 10 feet.
- 3) Participants are not permitted any practice or warm-up putts nor shall any one participate on more than ONE occasion. The distance of Golf Putt will not be disclosed to participant prior to Golf Putt. If more than one participant competing, each shot must be from a different location on the green while maintaining the distance as stated on the application. Designated target distance shall not be less than that stated on application.
- 4) Total number of attempts shall not exceed that stated in application.
- 5) An official witness (spotter) must be a non-participant and age 18 years or older and appointed by responsible tournament official or appointed by sponsor to adjudicate the contest.
- 6) A video tape will record each contestant(s) Insured golf putt.
- 7) The following categories of persons shall be deemed ineligible to participate: Any current or former touring or club professional, any current University or College Golf player, any current or former professional, or current or former members of Professional Putter’s Association.
- 9) No blocking or grooving of the target path is permitted. There can be no alterations to the putting green that would in any way enhance a participant’s chances of completing a successful putt.
- 10) Sponsor warrants that the target path is of a uniform surface.
